<b>Zidua™</b> (pyroxasulfone)	15	Prior to seeding or prior to emergence	glyphosate	Grassy weeds	None
<b>Heat® Complete</b> (pyroxasulfone + saflufenacil)	14 + 15	Prior to seeding and post seeding within three days	glyphosate	Broadleaf and grassy weeds	None
<b>Authority® Supreme</b> (pyroxasulfone + sulfentrazone)	14 + 15	Prior to seeding or up to three days after seeding	Aim® + glyphosate glyphosate	Broadleaf and grassy weeds	Crop restrictions on label
<b>Authority® 480</b> (sulfentrazone)	14	Prior to seeding or up to three days after seeding	Aim® + glyphosate glyphosate	Broadleaf weeds	Crop restrictions on label
<b>Heat®</b> (saflufenacil)	14	Prior to seeding or prior to emergence	glyphosate Authority®	Broadleaf weeds	None
<b>Express® SG*/Involve® 50 WDG</b> (tribenuron)	2	Minimum 24 hours prior to seeding	glyphosate (required) Aim® + glyphosate	Broadleaf weeds	None
